## **Updates from the City Clerk:**

• Reminder that this is the last week to vote early!

DEADLINES: Get a ballot mailed to you: Thursday, April 2<sup>nd</sup> at 5:00pm.

DEADLINES: Come in City Hall and vote In-Person: Friday, April 3<sup>rd</sup> at 5:00pm

• Election Day (April 7<sup>th</sup> from 7am-8pm) - If you come to vote on Election Day, you will be held to the 6ft Social Distancing requirement, which may result in voting lines that continue to <u>outside the building</u>. Please dress appropriately.

### **Updates from Community & Economic Development:**

Fond du Lac County, through Fond du Lac County Capital Resources, is providing loan opportunities for our business community. These quick and easy applications are put in place for you, our small business community, to help you during this time. This <u>loan opportunity</u> is limited to businesses in Fond du Lac County and the City of Waupun (Dodge Co. side is included) and is only available while the funding exist!

Waupun businesses are also encouraged to complete the city's <u>COVID-19 Business Impact Survey</u> to help community leaders better understand the effects that current circumstances have had on business revenue, staffing, and other resources.

Health care providers will give you recommendations for treating your symptoms without unnecessarily tying up an ambulance and overcrowding the emergency department and hospital.
