#### **Updates from the City Clerk:**

City Clerk, Angie Hull, would like to thank those who have used the My Vote WI site and made a request for a ballot be mailed to you. At this time, we have issued over 1000 ballots however, this is only 25% of registered voters, so we have plenty more voters out there!

Ms. Hull asks all residents of Waupun to reach out to your family, friends, and neighbors and encourage them to act now to request a ballot. Do not delay!

Be reminded the entire State of WI is voting absentee so our postal system is overloaded. If you wait until the deadline date of April 2<sup>nd</sup> to request your ballot be mailed, Ms. Hull is concerned it may not be returned by Election Day. We want your vote to count! If you have a true medical emergency, calling 9-1-1 is the right thing to do. If you have "flu-like" symptoms, please call a health care provider to discuss treatment options over the phone. Health care providers will give you recommendations for treating your symptoms without unnecessarily tying up an ambulance and overcrowding the emergency department and hospital.

The City of Waupun continues to follow recommendations from local, state, and federal agencies to establish preemptive measures to assist in reducing the spread of COVID-19.
