WAUPUN, Wis. March 31 2020 – In response to the COVID-19 pandemic here are the latest updates from the City of Waupun.

Updates from the City Clerk:

- Reminder that this is the last week to vote early!

DEADLINES: Get a ballot mailed to you: Thursday, April 2nd at 5:00pm.
Request a ballot at www.myvote.wi.gov

DEADLINES: Come in City Hall and vote In-Person: Friday, April 3rd at 5:00pm

- Election Day (April 7th from 7am-8pm) - If you come to vote on Election Day, you will be held to the 6ft Social Distancing requirement, which may result in voting lines that continue to outside the building. Please dress appropriately.
- The deadline to purchase your annual dog license is March 31, 2020. Due to the hardship of COVID-19, the City Clerk is eliminating the late fee for dog licensing for the 2020 licensing period (January 1- December 31, 2020).

Updates from Community & Economic Development:

Fond du Lac County, through Fond du Lac County Capital Resources, is providing loan opportunities for our business community.
