CITY OF WAUPUN COVID-19 UPDATE: May 11, 2020

WAUPUN, Wis. May 11, 2020 – In response to the COVID-19 pandemic here are the latest updates from the City of Waupun.

Today Gov. Evers released [Emergency Order 36](#) (effective immediately) to continue to turn the dial expanding allowed operations for nonessential businesses. All businesses impacted by this Order shall follow guidelines found on the Wisconsin Economic Development Corporation (WEDC) [website](#).

Last week, the Wisconsin Department of Natural Resources (DNR) have reopened state parks. However, due to COVID-19, hours and capacity have been modified. Therefore, please check please check <https://dnr.wi.gov/topic/Lands/apip/capacity.aspx> before heading out to your favorite park.

Updates from the Recreation Department:

The city tennis courts are now open. Since there are only two courts in each park, it has been decided to re-open Dodge and West End parks for tennis. Each court could potential hold 4 players per court for a maximum total of 8, which is still under the limit of the Governor's stay at home orders. Again, please use social distancing and CDC protocols.

The Batting Cages at Medema Fields and the Baseball Fields are now open for use. Please use CDC protocols when using the cages. Only 2 people per cage and no team play as we need to follow Wisconsin DHS health orders of 10 people and under.

Reminders:

If you are experiencing symptoms or worry you may have been exposed to the coronavirus, Dodge County residents are to call 1-877-998-0022 and Fond du Lac County residents are to call 1-844-225-0147 for more direction from health officials before going to a healthcare facility.

If you have a true medical emergency, calling 9-1-1 is the right thing to do. If you have “flu-like” symptoms, please call a health care provider to discuss treatment options over the phone. Health care providers will give you recommendations for treating your symptoms without unnecessarily tying up an ambulance and overcrowding the emergency department and hospital.
